Release, Assumption of Risk, and Waiver of Liability Agreement

As a condition of participating in this, Jared Sare Memorial Ranch Rodeo (JSMRR), each contestant or participant agrees that the Rodeo Committee, Arena Crew, Sublette County Fairgrounds and any volunteers or workers working on behalf of the Rodeo Committee (hereafter referred to as Committee) is not responsible for any injury to the contestant or damage or theft to property belonging to or used by the contestant involved in the Rodeo. Each contestant agrees to be responsible for all damages, theft or injuries that occur to the contestant or any property or animal owned or used by the contestant and to hold harmless the Committee for such injuries or damages. The contestant acknowledges that participating in the JSMRR, involves significant danger and risk of injury or death to person and personal livestock and on behalf of the contestant's personal representative, heirs, spouse, and next of kin, agrees and understands, as a condition of participating in the Rodeo, to hold harmless the Committee and all afore mentioned parties involved with the Rodeo for any and all injuries or damages to the contestant or any property of any animal owned or used by the contestant and agrees to personally assume all responsibility for any and all injuries or damages that may occur as a result of participating in this event. The contestant further agrees that any expenses or attorney fees incurred by the Committee for a breach of this agreement shall be paid by the contestant. The contestant voluntarily accept all risks associated with participating in the event and Waives all liability of the Committee and agrees to hold harmless the Committee and all afore mentioned parties connected with the Event for all injuries to the contestant's person or property owned or used by the contestant.

The contestant agrees that any cause of action arising from participation in the Rodeo or any cause of action pertaining to this agreement shall be filed in the County and State in which the parties entered into it.
